Construction Underway at Viamonte

It has been an exciting season for Viamonte at Walnut Creek, NCPHS' dynamic new community opening in 2020. Construction officially began at the Viamonte site on May 29, and the **Cahill Contractors** team is making fantastic progress. The team is currently excavating deep pits in the basement area, installing sub-slab plumbing, and continuing to work on the asphalt and wood walkways. The weekend of September 8 marks a special milestone: the installation of the tower crane!

Earlier in the spring, 235 attendees gathered at the Walnut Creek Historical Society for Viamonte's groundbreaking ceremony on May 15. Among the day's distinguished guests were Walnut Creek Mayor **Justin Wedel**, Walnut Creek Chamber of Commerce CEO **Jay Hoyer**, and members of Walnut Creek's Planning Commission and Design Review Committee. "It was a memorable day to see Viamonte's future neighbors connecting with one another," said **Allison Cervantez**, Vice President of Sales at the Viamonte Sales Center.

adjusts to the perfect temperature. This isn't a scene from science fiction; it's the new Smart Home prototype apartment at The Tamalpais.



A Conversation with Ronald Streitz, Senior Services for Northern California's Chief Fund Development Officer

Ronald Streitz brings 40 years of non-profit fundraising expertise to his role as Chief Fund Development Officer for Senior Services for Northern California. In this interview, Ron shares why he has “never regretted a day” of his career.

How did you become involved in philanthropy?

My first experience working in philanthropy was right out of college, when I worked as associate director of a retreat and conference center run by the Jesuit Province of Detroit. After five years there, I was hired by a consulting firm in Birmingham, MI, where I worked on capital, endowment, major gifts, planned giving, annual giving, and special events projects. My focus on planned giving, which lasted for more than 20 years, came later when I worked for Gleaners Community Food Bank in Detroit and structured a new legacy program as part of their endowment building plan, a \$20 million project.

What do you enjoy most about your work?

I enjoy helping people realize their wish for a better world in a way that aligns with their vision, values, and goals. This

involves discussing what is meaningful to them, how they can take care of themselves and those they care about, and how they can support a cause that is important to them. When there is a need, whether an emergency or day-to-day issue, people do step up to the plate and share their time, skills, and financial and material resources to address that need. Hearing about people’s motivation for doing so keeps me optimistic about the state of the world and our role in it.

What appealed to you about working at NCPHS?

NCPHS is aligned with my long-standing interest in how people age and the search for solutions to issues of aging. With the Baby Boom generation, we have one of the largest populations of people over the age of 65 we’ve ever seen. With that, challenges of wellness, aging in place, support services, and financial needs that affect quality of life will become even more prominent.

What do you like to do in your free time?

I enjoy gardening, beekeeping, walking the dog, home improvement, travel, movies, music, and reading.
