ADMISSION CRITERIA SHORT TERM REHABILITATIVE CARE

- Be insured through Medicare A and B or a contract HM0/PPO Medicare Advantage plan
- Require a three day Medicare qualifying stay in an acute hospital
- Require daily skilled nursing or oversight from a licensed nurse or therapist
- Be able to participate in treatment and make measurable progress during the course of care
- Have a solid discharge plan and arrangements for post treatment care
- Care is medically reasonable and necessary and ordered by physician
- There is an available bed
- Patients do not meet any of the exclusion criteria listed in this document
- Sequoia Living does not discriminate against residents in regards to sex, age, religion, ethnicity or race
- Patients require daily skilled nursing or therapy services, as defined by Medicare and CCRC guidelines

LONG-TERM CARE

Temporary long-term care (need for care for only weeks or months)

- Rehabilitation from a hospital stay
- Recovery from illness
- Recovery from injury
- Recovery from surgery
- Terminal medical condition
- Respite care

Ongoing long-term care (need for care for many months or years)

- Chronic medical conditions
- Chronic severe pain
- Permanent disabilities
- Ongoing need for help with activities of daily living
- Need for supervision
- Need for daily ADL support

Criteria for LTC

The need for long-term care help might be due to a terminal condition, disability, illness, injury or the infirmity of old age. Patients requiring long-term care will meet the insurance coverage benefit plans or private fund policies and the facility's pre-admission packet completed.

An exclusion criterion includes the following specific or similar conditions or care needs:

- Clinically unstable
- Electronic cardiac monitoring
- Unstable GL bleeding
- Uncontrolled bleeding
- Uncontrolled hyper-or hypo-tension
- Brady-arrhythmia or tachyarrhythmia
- · Unstable respiratory condition
- Tracheotomy patient off ventilator less than 24 hours and in need of more that q-shift suctioning
- Ventilator dependent patients
- Unstable metabolic status
- IV chemotherapy including central lines
- Immediate post-operative care
- Requirement for separate negative air flow room
- Lab tests more frequent than daily, except bedside blood glucose monitoring
- Traumatic Brain Injury (TBI); will be evaluated on a case-by-case basis
- · Hyperbaric treatments
- Chest or Cranial drainage tubes
- Traction
